FOURTH AMENDMENT to the CONTRACT FOR SALE AND PURCHASE

This **FOURTH AMENDMENT** (this "Fourth Amendment"), made as of this 1st day of June, 2011 (the "Fourth Amendment Effective Date"), by and between STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, ("State") and CSX TRANSPORTATION, INC., ("CSXT"), amends that certain CONTRACT FOR SALE AND PURCHASE dated as of November 30, 2007, by and between State and CSXT (the "Original Contract").

WHEREAS, the Original Contract was previously amended by the Corrective Amendment to the Contract dated January 4, 2008 (the "Corrective Amendment"); by the Second Amendment to the Contract For Sale and Purchase dated as of March 29, 2010 (the "Second Amendment" with the Original Contract, as amended by the Corrective Amendment and the Second Amendment being referred to as the "Second Amended Contract"); and by the Third Amendment to the Contract For Sale and Purchase dated as of December 20, 2010 (the "Third Amendment" with the Original Contract, as amended by the Corrective Amendment, the Second Amendment and the Third Amendment being referred to as the "Third Amended Contract"), and

WHEREAS, the Parties desire to further amend the Third Amended Contract as set forth herein (as further amended herein the "Contract"). Except as expressly provided herein or unless the context otherwise requires, capitalized terms have the meanings assigned to such terms in accordance with the Third Amended Contract or if not defined therein, the meanings assigned to such terms in accordance with the Escrow Agreement.

NOW THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth, the parties hereto, intending to be legally bound, agree as follows:

Section 1. Dates.

- (a) The date of <u>June 1, 2011</u> appearing in each of <u>Subsections 17.01(e)</u> and <u>17.02(e)</u> of the Third Amended Contract is amended to December 1, 2011.
- (b) The date of <u>January 31, 2011</u> appearing in <u>Section 6.01</u> of the Third Amended Contract is amended to <u>October 1, 2011</u>.
- (c) The date of <u>June 1, 2011</u> appearing in <u>Section 6.01</u> of the Third Amended Contract is amended to <u>December 1, 2011</u>.

Section 2. Counterparts.

This Fourth Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute but one and the same instrument.

Section 3. No Other Changes.

Other than as expressly set forth above, the terms and conditions of the Third Amended Contract remain in full force and effect.
