### Meeting was called to order by Chair Janer at 2:00 PM

### Pledge of Allegiance and Confirmation of Quorum

#### Announcements/Recognition

September 18-22, 2023, was Rail Safety Week, which is a nationwide effort to raise awareness about the importance of being safe around railroad tracks. SunRail's campaign entitled "Avoid the Impact" features the devastating effects that a train strike can have. The campaign received strong support by our local media channels and social media outlets. There was 100% participation from all law enforcement agencies along the corridor at 21 different grade crossings and issued warnings and citations to unsafe drivers.

Mr. Charles M. Heffinger made a special announcement in recognition of Law Enforcement Officers' (LEOs) appreciation. A certificate and commemorative SunRail coins were given to honor the following: agencies the City of Altamonte Springs Police Department, Edgewater Police Department, Kissimmee Police Department, Longwood Police Department, Maitland Police Department, Orange County Sheriff's Department, Orlando Police Department, Osceola County Sheriff's Department, Sanford Police Department, and the Winter Park Police Department. A group photo of the Commissioners and the law enforcement agencies was taken following the recognition ceremony.

Adoption of the meeting minutes from July 27, 2023, passed unanimously.

### **Public Comments:**

**Presenter:** Chair Janer

Speaker – Mr. Calvin Clark of Polk City, Florida and a graduate of UCF downtown campus who uses SunRail weekly to get to class.

- He would like to know if there has been any progress or action on expanding SunRail into Polk County. He understood that there was a recent Transit Concept and Alternatives Review Study completed, and he would like to know if there has been any update to the results.
- Is there a possibility to expand including service on weekends as well?

Chair Janer stated that Mr. Clark's comments would be taken into consideration by the Board.

Speaker – Mr. Steve Walton of Orlando, Florida. He is a regular SunRail rider on Wednesday evenings and is concerned about how the Amtrak train interacts northbound with the Winter Park Station. The Amtrak trains completely block downtown Winter Park. He is specifically concerned about the northbound train because he rides the last train on Wednesday evenings at 8:43 p.m.

southbound from Winter Park to Church Street Station. If the Amtrak train arrives late, as it occasionally does, it completely blankets the Winter Park side of the station so pedestrians cannot get over to the southbound side. This problem could apply to other common stations. Mr. Walton suggested if the SunRail train arrives and it is blanketed by the Amtrak train, the SunRail train should stop and wait until Amtrak leaves allowing passengers to get over, possibly buy a ticket, and get on the SunRail train. Otherwise, he is left standing in the dark, in the rain, and with no other outbound trains and then has no way to get home.

Chair Janer stated FDOT acknowledged Mr. Walton's comments, making some notes, and will see if they can address this issue. Mr. Heffinger offered to speak with Mr. Walton and address his concerns following the meeting, and Mr. Walton agreed.

Agenda Item: Reports – Customer Advisory CommitteePresenter: Luis Nieves-Ruiz

Mr. Luis Nieves-Ruiz was not present, and a report was not presented.

### Agenda Item: Reports – Technical Advisory Committee Presenter: Tawny Olore

- TAC has not met since the last Central Florida Commuter Rail Commission Meeting.
- Ms. Olore advised that the next TAC meeting will take place on Wednesday, October 11th and will have a report for the October 26th meeting.

Chair Janer recognized Secretary Tyler

- Secretary Tyler was appreciative of the comments and feedback from the community. Osceola County expansion is being led by FDOT District 1 office in Bartow and Secretary Tyler offered to speak with Mr. Calvin Clark following the meeting.
- FDOT reserved \$7 million last fiscal year to do safety improvements along the corridor. The FRA awarded a Consolidated Rail Infrastructure and Safety Improvement (CRISI) grant that basically doubles that money bringing the \$7 million to almost \$14 million of improvements on this corridor over the next couple of years. There have been 110 crossings identified needing some type of improvements ranging from additional striping, pavement markers, constructing vehicle escape lanes, installing sensor activated LED "Do Not Stop on the Tracks" signage, signalization adjustments, and mitigate pedestrian trespassing with additional channelization and fencing along the corridor.

Agenda Item: Reports – Agency Update

• Hurricane Idalia Response

- In anticipation of landfall on August 30<sup>th</sup>, service was temporarily suspended August 29<sup>th</sup> to prepare the corridor.
- Tracks and signals were inspected as debris was removed and gates reinstalled on August 30<sup>th</sup>.
- Service completely restored on August 31<sup>st</sup>.
- Community was fully informed throughout the process through media releases, online/app updates, and social media.
- New and Improved Train to Plane
  - On August 21<sup>st</sup>, LYNX increased the number of buses and frequency of routes 111, 11, and 42 from Sand Lake Station to Orlando International Airport.
  - New campaign highlights:
    - Increased frequency of buses for a quick and easy connection.
    - Advanced wayfinding signage.
    - New marketing campaign will target both commuters and travelers.
- College Week on SunRail
  - SunRail partnered with colleges and universities in Central Florida to bring back College Week.

Agenda Item: Discussion Items – Rail Safety Week, Phase 2 North, Fare Collection System Update Presenter: Mike Heffinger

- Rail Safety Week was September 18-22, 2023
  - There are 13 law enforcement agencies along the corridor.
  - First year out of the nine years of operating that all law enforcement agencies have participated.
  - Conducted safety inspections at 20 CFRC crossings.
  - Overall statistics: Stopped 272 vehicles, and 90 warnings were issued. Some stopped on the tracks and were using their phones to text.
  - Handed out hundreds of ID cards informing the community what to do on the tracks.
- Avoid the Impact: The 2023 SunRail Safety Week campaign was designed to stop readers in their tracks as they consider the far-reaching implications of making rail safe decisions.
  - Featured SunRail crews and law enforcement in videos describing the different emotional, financial, psychological, and physical impacts of a collision.
  - Promotion with community partners.
  - Tremendous, earned media throughout the week with local news organizations.
- Operation Safe Track: Largest law enforcement presence to date for education and grade crossing enforcement days.
  - Over 20 grade crossings.
  - All counties and cities of the CFRC participated.
  - Strong presence with educational handouts, warnings, and citations.
- Phase 2 North Construction Update
  - DeLand Station Construction Progress
    - Front entry excavated while maintaining access to working Amtrak Station.
    - Main parking area cleared 102 spaces.
    - Drainage and retention pond in development.
    - Concrete footers for the columns and station platform under construction. Rebar embedded in the grade beams and concrete columns will tie the entire platform together.
  - Phase 2 North Construction Progress
    - Public outreach and resident meetings continue along the corridor.
    - Grade crossing improvements and implementation of safety initiatives like dynamic envelopes activated at key locations.
    - Laying 3.6 miles of new double-tracking underway.
- Fare Collection System Update
  - SunRail looked to upgrade the existing legacy fare system to accomplish three key objectives: (1) Provide greater customer ticketing options such as Mobile ticketing; (2) Streamline operational and maintenance costs; and (3) Manage a faster and more efficient servicing protocol.
- SunRail's Advanced Ticketing System:
  - SunRail's new ticket vending machines have arrived and are being inspected in FDOT's warehouse preparing to be installed.
  - Tickets will print a QR code on standard paper stock, greatly reducing costs.
  - 67 TVMs 22 are full service and 45 are cashless.
  - 100 Ticketing Validating Units (TVUs) and 28 Hand-Held Ticket Validators (HHTV) have arrived and are being tested in the FDOT warehouse.
  - Advanced TVUs will be able to read single-day paper tickets, SunCards, and mobile tickets from your Smart phone.
  - Conductor Hand-Held Validators are smaller, faster, and more efficient.
  - Mobile Ticketing:
    - Compatible with Apple and Android Smart phones.
    - Saves time by allowing users to purchase train tickets in advance.
    - Easy to manage rider SunCard accounts.

- Greatly reduces the need and expense of printing single-day tickets and SunCards.
- Mobile Ticketing Custom Screen Development:
  - QR code generation for ticket purchase and validation.
  - Animated Central Florida custom cityscape background.
  - Ticket validation for conductor inspection.
- Testing and Rollout Times:
  - Mobile Ticketing App
    - Internal Testing Current
    - External Test Group includes both TAC and CAC members October 2023
       Public Release November 2023
  - Ticketing Vending Machines and TVUs
    - Platform Installation February 2024
    - Final Installation March/April 2024
- Mayor Demings asked when was the projected completion date and service start date for Phase 2 North?
- Mike Heffinger responded anticipated construction date based on the construction time schedule is early to mid-summer. The final date in the construction progress is May 15, 2024. The goal is to finish earlier than that date.
- o Mayor Demings asked what is the maintenance schedule for painting or washing the trains?
- Mike Heffinger responded washing is scheduled to be every two weeks. There is no wash facility onsite, so the rolling stock is taken to the Amtrak Auto Train Facility in Sanford to get washed. Brightline also has a state of the art wash facility at their intermodal location west of the airport. FDOT is currently in negotiations with Brightline to see if we can take some of the SunRail cars over there to test them at their wash facility which is supposed to be able to accommodate SunRail's trains.
- Mr. Heffinger also stated that Commissioner Dallari asked about who owns the media data that Moovel receives? He replied that the data is owned and controlled by FDOT.
- Another question that came up was about electric locomotives. At the upcoming APTA Conference scheduled for the week of October 8<sup>th</sup>-11<sup>th</sup> at the Orange County Convention Center, an electric locomotive is being brought in for display. For any future locomotives/cars, we would be looking at about \$15-20 Million dollars vs \$80 Million for electric locomotives. Keep in mind that this does not include the costs required for upgrades to our existing infrastructure to accommodate the overhead lines that are needed for those electric locomotives.
- Commissioner Janer indicated that she was glad to hear the ticketing system is being replaced especially after all these years and is looking forward to the date of final installation and hopefully a go-live date. Ms. Janer's concern was with the non-cash machines given that some people prefer to use cash. Mr. Heffinger replied that 45 of those machines will be cashless. Ms. Janer responded that as long as there is a cash option available to customers, that alleviates her concern.
- Secretary Tyler spoke up and indicated that FDOT's goal for revenue service on Phase 2 North is May 2024 and his team continues to remain laser focused on that commitment.

Agenda Item: Discussion Items – Sunshine Corridor Update Presenter: John Tyler, P.E.

- Ridership Model Strong ridership to OIA, OCCC, and South I-Drive.
- Cost Estimates Over \$2 billion high-level capital cost estimate from OIA to OCCC.
- Utilizing recent experience to develop cost estimates feedback from Brightline and the airport and our own actual construction cost experience. Keep in mind that FDOT has not had enough time or money to really dive deep into the costs since no design has been done. The goal here was to get to an order of magnitude to better understand what we are all looking at here. The costs are significant. This is a significant infrastructure project that would extend from the airport to the OCCC and is based on a major multi-use rail corridor serving both intercity passenger and commuter service. FDOT looked at the infrastructure (track, signals, stations, etc.) that would be needed to build this mega project. It is not an exact number, but the estimate does give us a range.

- Feedback is Driving Adjustments:
  - Started sharing these results with the Working Group and we are currently looking for feedback to ensure nothing is being missed over the last month.
    - Transfer Location Options where is the transfer going to take place (e.g., dedicated transfer location along the mainline or could you utilize existing stations as transfer points)?
    - Levels of Service how often will people be waiting for a train 15, 30, 60 minute headways? How long will you wait or where are you going to wait?
    - Quality of Service affects people's willingness to use the system and a lot of details still being worked through to present as many options as possible.
    - All this work will continue to progress over the coming months.
  - Based on the modeling efforts, the Department is still trying to bring all this useful information into the analysis so that realistic operations costs can be developed. Capital costs is one thing, but we also need to make everyone aware of the day to day operations costs it will take to operate this system.
- Next Steps
  - o Final Report by Working Group sometime anticipated later this fall.
  - Multiple paths forward for the Commission to consider.
  - FDOT will be evaluating the funding outlook for future rail and transit investments.
  - Continue to work on the TCAR public involvement effort scheduled for late October through November.
- Commissioner Dallari asked when FDOT would like to receive input?
  - Secretary Tyler responded as soon as you are ready to give it to me.








## AVERAGE DAILY RIDERSHIP

SEP - OCT AVERAGE - 4,002







- What is Mobility on Demand?
- How will it help our system?
  - Cost effective
  - Provides coverage to low demand areas and reallocates resources to high demand areas
  - Staffing relief
  - Better service to the public



### **Current Service Options in West Volusia: Fixed Route**




- Runs along major corridors throughout West Volusia, with three circulator routes in Deltona.
- Three feeder routes to the DeBary SunRail Station
- Service is generally Mon-Sat, 5:30a-8p
- Every 30-120 min frequency
- Fare: \$1.75

### **Current Service Options in West Volusia: Paratransit**




- Service for ADA & Transportation Disadvantaged population
- Door-to-door service
- Hours mimic the Fixed-Route hours for ADA and 6a-7p for TD
- Trips must be scheduled at least the day prior to travel
- Fare: \$3.00



### How does it Work?

- Schedule trips via app, website, or phone call
- System routes a nearby vehicle to pickup the customer
- System is continually monitoring for ride requests and routing vehicle as efficiently as possible: Riders may share the vehicle with other riders
- Requests can be fulfilled within 30 minutes



### **VoRide Implementation**



- Launching Tuesday, December 5
- DeLand Zone first
- No route changes initially
- Deltona/Orange City/DeBary Zone to be implemented in near future
- Fares: \$2.00 w/ free transfer to/from Fixed Route system
- Service Hours: Mon.-Fri.: 6a-9p & Sat. 7a-7p



### **Future Plans**

- The existing Votran Flex Zones in New Smyrna Beach may be transitioned to VoRide service.
- Additional areas on the Eastside are being considered.
