



## CFRC SAFETY TRAINING REQUEST INSTRUCTIONS

*The Federal Railroad Administration (FRA) requires railroads and/or their contractors to provide roadway worker protection (RWP) training to any worker whose job duties include inspection, construction, maintenance, or repair of track, bridges, roadway, signal and communication systems, electric traction systems, roadway facilities, or maintenance machinery on or near the track or with the potential of fouling a track (FRA 49 CFR 214).*

*The RWP training is a 4-hour, classroom-based training available in English. For non-English speaking trainees, please make prior arrangements to have a translator from your company attend class. Requalification is required annually.*

*Participation is \$125.00 per person with payment due at or before the time of training via company check, personal check, or money order payable to Alstom Mass Transit Corporation. Annual rates will be re-evaluated based on increases in the market and our current pricing will be adjusted accordingly.*

- *Minimum class size is 6 participants for onsite classroom training with a maximum of 14.*
- *Scheduled participants must cancel with no less than forty-eight hours' notice or they will be charged for the class.*
- *Special arrangements may be made for off-site classes with 25 participants or greater within a 50-mile radius of 801 SunRail Drive, Sanford FL 32771. An additional \$350 fee will apply to off-site classes, and all off-site classes require prepayment at least 72 hours prior to the scheduled class.*
- *Dress for class is casual, however, sandals, flip-flops, tank-tops, and shorts are not allowed due to the nature of the facility and for safety purposes.*
- *Participants should come prepared to take notes and complete a written RWP Exam at the conclusion of their training.*
- *RWP cards will be issued after successful completion of class and when payment is received in full.*
