Minutes

The meeting was called to order by Renzo Nastasi at 2:00 p.m.

Pledge of Allegiance

Quorum was not met.

Public Comment:

No public comments.

Agency Update

- Group Ride Presentations
 - o "We ride SunRail once a month to see our grandchildren." AARP Member
 - 30 AARP member Group Ride in July promoting senior-friendly community engagement.
 - Promoted SunRail transit to over 500 attendees at the Osceola County Government Resource Fair.
 - 26 students and teacher Group Ride from the Conklin Davis Center for the Visually Impaired promoting mobility awareness and accessibility on SunRail.
 - Encourage each of the Technical Advisory Committee (TAC) members and their agencies to reach out within their communities to people who would like to do a group ride. Evolve is prepared to handle that for them. However, it should be noted that they do have to pay for the group rides. We've had a lot of success with that this year and are looking forward to doing some more. Most of those occur during the midday. We've had some large groups, and I think it's been a big success. We've gotten a lot of positive comments back from people who have been using the system.
- Average Daily Ridership June 2025 Average 5,181 Up 11% year over year. The line is above where it was last year, which is good. This is typically where we have a little slow down when kids go back to school. So, if we can keep those numbers up close to 5000, I think we're going to have another big year this year.
- Onboard Stats ADA June 2025 Average 28; Bicycles June 2025 Average 243. We've also

seen quite a few bicycles are still using the system as well.

- Boardings by Station Ridership June 2025 Total Ridership = 108,796
 - O As far as our station performance is concerned, LYNX continues to be our largest station with the transfers that we have there, followed by Winter Park. Kissimmee is pulling up real close as well with those stations. DeLand and DeBary still doing well up in Volusia. DeLand has been a big success up there as well.
- On-Time Performance June 2025 Contract Goal=95%; Contract=97.98%; Actual=92.38%
 - o 21 Operating Days; Ran 840 Trains
 - o We were very fortunate with the weather in June and would like to see that on-time performance stay up high.
- FY 24/25 Operating Budget Update
 - o Operating Costs, Capital Maintenance and Consultant Support Budget \$80,649,071 vs. Actual \$70,420,873
 - O As far as our overall budget is concerned, we are going to be looking at a slightly different format including the capital plan as well going forward. This was through the state budget year. As you can see, we stayed within our budget for O&M. There were some items that came in a little under as far as the invoicing period, so a lot of what you see there is actual throughout June. Those invoices still follow into July and August.
 - o Operating Revenue Budget \$30,287,997 vs. Actual \$30,205,741
 - Still consistent with our revenue from farebox all the way down through our system usage fees. A little bit higher on our ancillary revenue and that's due to some of our advertising and wraps that were paid for by some of our supporters.
- Renzo Nastasi: I would like to ask you to continue our conversation with Mr. Carman and Mr.
 Cooke regarding the potential leasing of locomotives. I understand it might be at the item of
 discussion at the upcoming board meeting. I know it did last time. However, I haven't seen the
 agenda.
- David Cooke: I'm not aware yet of that agenda and going over it with the Commission.

LYNX Bus Connectivity

- For the month of June, we experienced a 5% increase when compared to last year. Total fiscal year is showing a 3% increase.
- June had a combined decrease of 7% on fixed routes and an 88% increase on Neighbor Link. The Sand Lake to airport corridor had a 20% increase in ridership.
- We attribute this decrease in fixed route ridership to the discontinuance of Link 155 in December of 2024 and the large increase in Neighbor Link ridership to some of those passengers from Link 155 switching over to Neighbor Link 831.

Votran Bus Connectivity

- DeBary Station Bus Connectivity for the month of June we had pretty good ridership, little bit lower each month. Mainly because we're seeing some higher numbers in DeLand. So, people are now moving to ride from DeLand.
- VoRide-SunRail Connectivity We provide VoRide on the west side of the county. It's our
 micro transit service but we do provide rides to and from the DeBary and DeLand Stations.
 Those numbers continue to rise. We're seeing increases in that at both stations with an average
 monthly ridership of about 13.
- DeLand Station Circulator Connectivity We have a circulator there that is mainly operating from 9:00 a.m. to 5:00 p.m. to downtown DeLand and back with some other bus routes serving the early morning hours and late-night hours. We're seeing steady ridership with over 450 each month and an average daily ridership of about 23 people.

Informational ItemsPresenter: Mike Heffinger

• SunRail is pleased to present a proposed 42-train service design to accommodate late-night riders while leveraging improved system management to help minimize delays. This presentation outlines the proposed schedule of additions and adjustments aimed at delivering the best service possible.

- We first propose a northbound train departing at 8:45 p.m. from Poinciana. Currently there's a 2.5-hour gap 7:25 p.m. through 9:55 p.m. between the northbound trains leaving Poinciana. We have a train, the P333, that departs DeLand at 4:40 p.m. and arrives in Poinciana at 6:28 p.m. After finishing its run, this train essentially dead heads to Sanford to prepare for the next day's run. This train has an engineer, a conductor, and a security guard, and can essentially stop at the stations and pick up passengers on their way to Sanford and continue to DeLand where it will then dead head back to the OCC in Sanford with no additional operational cost. We propose that this train dwell at the Poinciana Station from 6:01 to 8:45 p.m., then departs from Poinciana Station at 8:45 p.m., picking up passengers along the way, free of any additional operational cost
- We also propose adding a southbound train at 9:55 p.m. from DeLand. Currently, the last train leaves out of DeLand southbound at 7:55 p.m. That's kind of early for the late-night riders on Friday. Train P328 departs Poinciana at 4:15 p.m. and arrives in DeLand at 6:01 p.m. After finishing its run, this train, essentially deadheads back to Poinciana to prepare for the next day's schedule. This train has an engineer, a conductor, and a security guard and can essentially stop at the stations and pick up passengers on the way down to Poinciana with no additional operational cost. We propose that this train dwell at DeLand Station from 6:01 to 9:55 p.m., then depart from DeLand Station at 9:55 p.m. picking up passengers along the way, also free of any additional operating cost.
- We also would like to propose changing the departure time of Train P325 from the current 2:45 p.m. to 2:35 p.m. from DeLand. The remaining run scheduled run times would stay the same. This change is proposed due to a very tightly scheduled train meet between the Train P320 coming from northbound DeBary. The current departure time from DeLand for train P325 forces it or train P320 to wait for the other to clear the single main track area between the DeLand and DeBary Stations. This is usually due to one of the two SunRail trains being behind schedule resulting from signal equipment issues and passenger loading and unloading delays. The addition of these two time slots would add late night service to both and give greater flexibility to our patrons. Also, since the corridor was completed basically a year ago in August of 2024 with adding to the trip to DeLand, we have noticed some areas on the corridor could use updated run times. These numerous one and two-minute changes do not change the overall runtime between DeLand and Poinciana but redistributes the timing areas where you have an extra or not enough time. This will allow for a much more accurate schedule instead of trains coming in a minute or two late.
- *Renzo Nastasi:* Thank you, Mr. Heffinger; sorry for not looking at the agenda and noticing you did have this presentation. I think the big take away from this is that there are no additional costs running the extra trains, i.e. operating, personnel.
- *Mike Heffinger:* In these trains, the engineer, the conductor, and the security guard are already on the trains. What happened a year ago when we added the DeLand Station, to keep the exact same times and minimize scheduled impacts, we were able to add this train that dead heads back and forth. We have two trains going from DeLand to Poinciana and then they don't have another run until the next day. They run back to the other station. We have two of those. One dead head from DeLand down to Poinciana and one dead head from Poinciana to DeLand. There's no additional fuel; the cost of fuel has already been spent. The conductors are already on board. The engineer is running the train, and the security guard rides the train at the same time. Essentially, there's no additional cost to add an extra train for that run. Plus, we have a 2.5-hour

break in service from Poinciana going northbound in the evening. It's a long time, so we put that 8:45 p.m. departure there. We also have extended the two hours to leave DeLand a little bit earlier in the evening.

- Renzo Nastasi: More service, no additional cost.
- *Mike Heffinger:* More service, no cost.
- Lou Beato: When is the schedule going to become effective?
- *Mike Heffinger:* Currently, we don't have time. We're looking maybe around August. That's the only time they would do. So right now, we're not taking away any time, we're only changing one 10 minutes in DeLand, which we will work with Bobbie King. Then the other times a minute here or there. Normal stations wouldn't have any difference. The only thing is we would have an extra train at 8:45 p.m. northbound departing Poinciana and an extra southbound train at 9:55 p.m. departing DeLand.
- Lou Beato: The reason I ask is because we typically print the schedule. Is this going to take effect in August 2026?
- *Mike Carman:* No, it will likely be October 2025.
- Lou Beato: So, we won't be able to publish an updated schedule until January with the links.
- *Mike Heffinger:* We've got our marketing group that does a fantastic job. We will go above and beyond to be able to market those. It's an advantage to leave early. It may not leave too early out of Poinciana. In Kissimmee and DeLand, that's a busy time to wait 2.5 hours for a train.
- *Lou Beato:* You mentioned Train P325 specifically leaving earlier at DeLand but having no effect on the schedule as it travels south. That's my train, so can you confirm that?
- Mike Heffinger: No, Sir. We don't want to mess with that.
- **Bobbie King:** Obviously, the hours impact bus connectivity. I know in our case we would not be able to meet those times. LYNX may have the same scenario. Adding the later times, there may not be bus connectivity for our stations.
- *Arturo Perez:* The southbound train that leaves DeLand at 8:45 p.m. arrives at the Poinciana station at what time?
- *Mike Heffinger:* The northbound train leaves Poinciana at 8:45 p.m. and that train arrives in DeLand roughly at 9:55 p.m., but that's not the train that would be used to go southbound.
- *Mike Carman:* The 9:55 p.m. train southbound out of DeLand gets into Poinciana at 11:38 p.m. That's essentially the last train.






AVERAGE DAILY RIDERSHIP

July 2025 Average - 5,010




ONBOARD STATS

RIDERSHIP JULY 2025










